A Message from Leadership

For the Colorado Coalition Against Domestic Violence (CCADV), 2016 was transformative. The Coalition worked diligently to build a social change campaign for launch in 2017: Stand Up Colorado! CCADV's Housing Program was unveiled in April and has already impacted the primary barrier to survivor safety, stability, health and well-being in our state. We wrapped up two successful three-year projects in partnership with rural member programs across the state: the Coordinated Community Response Team and Latin@ Outreach Projects. CCADV's membership expanded from 73 to 101, the most significant growth in years and an indicator of a healthy Coalition. Most importantly, we created an opportunity for our constituents to once again have a voice in leading the domestic violence movement in Colorado: CCADV's Survivors Caucus.

In these times, you may feel uncertain about the anti-violence movement's future and may wonder what we can do to further advance our cause in the face of such division and legitimization of misogyny, rape culture, racism and xenophobia. As compassionate communities who have advocated for years to end violence, it is important to remember that our collective values of respect, equity, inclusion, diversity, integrity, empowerment, and self-determination have not changed. Now is the time to reaffirm our values and grow even stronger as a Coalition.

As a movement rededicated to social justice, we lead with love and compassion, knowing when to lead and when to follow, never letting fear override our determination. Reaching Out

As a statewide coalition, CCADV is deeply committed to serving the entire state, greatly valuing both urban and rural inclusion. Through its Statewide Rural Latin@ Outreach Program, CCADV developed a culturally-engaging project for rural Spanish-speaking populations; and worked to centralize survivor safety through its rural Coordinated Community Response Project. CCADV serves as a resource for others wanting to strengthen rural organizations and coalition structure and services.

Supporting Leaders

CCADV recognizes the importance of cultivating and advancing the leadership capacity of DV program staff.

CCADV supported the development of Latina leadership in advocacy by providing financial and staff support so that 5 DV programs could send Latina advocates to participate in the Colorado Immigrant Rights Coalition Conference and the National Latino Leadership Network National Conference and Latina Advocates could attend the Colorado Latina Leadership Summit, and 8 Latina advocates could travel to the Arte Sana National Conference

Advancing Expertise

CCADV provides extensive training and technical assistance to advance effective interventions based on best practice. We use a feminist-based, trauma-informed approach to promote the safety and wellbeing of survivors and communities through an anti-violence, survivor-centered, anti-oppression framework.
